Interview questions (KIIs) - Trade Sector

Sector Performance:

- How would you describe the current state of the Trade sector in Lebanon? (e.g., thriving, stagnating, evolving, etc.)
- What was the overall turnover of the trade (wholesale/retail) sector in 2023? Did it increase or decrease when compared to the year 2022 (in dollar value)? By how much?
 - O Did it increase or decrease when compared to the year 2019 before the crisis in dollar values? By how much?
 - o How much does it represent of GDP currently?
 - Is there some further improvement in the first quarter of 2024? In which subsectors?
 Why?
 - What are the top performing subsectors? Why?
- What are the subsectors that witnessed a decrease in their turnover? Why?
- Have sales of locally-made products on the local market increased last year in 2023 when compared to 2022? What about when compared to the year 2019 before the crisis in dollar values?
- Could the trading sector get more involved in the distribution of locally-produced goods on the domestic market and abroad?
- What are the incentives that the government can create to encourage traders to engage more in the distribution of local products on the local market and abroad?

Workforce and Skills:

- What is the size of the total workforce employed in the trade (wholesale/retail) sector?
 - What is the percentage of Lebanese workers?
 - o Does the trade sector suffer from a lack of skilled human resources?
 - What are your proposals to address this problem?

Business Environment and Challenges:

- Are salary adjustments affecting your profit margins?
- What are the laws that are unfavorable to the trading sector that need to be amended?
 - What are the taxes in the 2024 budget that target traders and that must be challenged legally?
- What must the authorities do to fight dumping?
- What must the authorities do to fight smuggling?
- What must the authorities do to protect brands distributed by traders from counterfeiting activities?

Legislation and Regulations:

- What are the new laws that need to be passed to create a favorable business environment for traders?
 - What are the laws that are still being deliberated in Parliament that would create a favorable business environment for traders?
 - Are some existing laws unfavorable to the industrial sector (such as the one dealing with non-residential rent)?
- What are the administrative formalities that are encumbering the activity of traders that need to be streamlined (exports, imports, tax payments)?
- What are the taxes/customs duties that specifically target traders and that must be lowered or removed?
- What are your demands regarding the need to regulate the involvement of Syrian refugees in business activity?
